A. CALL TO ORDER

D. PUBLIC COMMENTS

Charley Wilson, representative of the Independent Special Districts of Orange County (ISDOC) was visiting the meeting to support the Board to vote for re-election of the incumbent ISDOC members to new terms on the Board of LAFCO (see agenda item L.2)

E. APPROVAL OF MINUTES

1. Meeting #556 of February 23, 2010

Motion was made by Vice President Levinson, seconded by Director Schwartz and passed 4-0-1 (Director Laster abstained as he did not attend the February meeting) to approve the minutes of meeting #556 of February 23, 2010.

F. SECURITY ACTIVITY REPORT

1. The monthly report for February 2010 was presented for review.

The security discussion this month centered around the next item regarding theft prevention in the community.

2. Community theft prevention program.

Orange County Sheriff Deputies of the Dana Point Police Department were present tonight to discuss some simple things property owners in the Beach Road community can do to prevent theft. It was pointed out that 40% of the property crimes committed in Dana Point occur in unlocked vehicles. If owners would be more mindful of locking doors and hiding valuables left in their vehicles this would give the Police 40% more time to go after bad guys instead of spending their valuable time chasing after such easily preventable crimes.

H. ENTRY PROJECT PROGRESS REPORT

Dave Gutierrez reported that cost estimates for the porous asphalt parking area are much less than originally thought and with the elimination of the proposed bridge over the drainage channel, the overall project cost is unaffected. Permit processing with the City is moving along well and a grading permit should be issued within the week. There is no definitive word at this time when construction can actually get underway.

There is no immediate threat to the public but the damage should be corrected before it becomes a larger and more expensive problem.
