D. PUBLIC COMMENTS

E. APPROVAL OF MINUTES

1. Meeting #557 of March 30, 2010

<u>Motion</u> was made by Director Schwartz, seconded by President Bell and passed 3-0-2 (Directors Laster and Levinson were absent) to approve the minutes of meeting #557 of March 30, 2010.

F. SECURITY ACTIVITY REPORT

1. The monthly report for March 2010 was presented for review.

Securitas Branch Manager Brian Sanchez delivered on the Board's request for an emergency hand-wind up radio for use in the guard shack in the event of a power outage during an emergency event.

Manager Russell reported that all User Fee and RR parking program fees have been billed out and are now paid in full.

H. ENTRY PROJECT PROGRESS REPORT

Manager Russell introduced Jim Steinkamp as the recommended candidate for Superintendent of the entry improvement project. Mr. Steinkamp has over 40 years of construction management experience and has supervised over \$300 million worth of residential projects. His current employment with Lennar Homes is slow and Jim is available for three months to step in and manage our project. Jim would be a full time superintendent and would be responsible for coordinating, scheduling and directing all elements of the approved grading/landscape/architectural/structural plans and specifications. He would also be responsible for evaluating/quantifying and pre-approving all subcontractor invoices prior to submittal for progress payments.

Motion was made by Director Schwartz, seconded by Director Bancroft and passed 3-0-2 (Directors Laster and Levinson were absent) to hire Mr. James Steinkamp as the Entry Project Superintendent at a rate of \$6,000.00 per month including telephone and miscellaneous project-related expenses for a three-month period with an option to extend the position for one additional month and with the time period to commence immediately.
