Current Securitas Contract/PPACA postponement

Good morning Joe and Board Members,

On July  $3^{rd}$ , the Obama administration took action to delay the employer mandate for providing affordable health care to employees. The mandate has been moved out to 2015 which brings into question your contract increase that was just approved by the Board that included the PPACA increase for the last 6 months of this fiscal year (January thru June 2014). The per-month increase is \$2184.00 x 6 mos. = \$13,104.00.

At face value, it would appear the contract should be adjusted to reflect this change in the PPACA mandate. I know Securitas keeps you busy but with 8 working days remaining before the next Board meeting I would like to have a contract amendment proposal prepared and ready for the Board to review on July 30<sup>th</sup>.

On another note, I would like to discuss with you the issue with possible pay increases for the officers working this post. I don't know when they last received an increase and perhaps this would be an opportunity to give it some thought. Morale is everything and my job is to guarantee performance out of the service provider, which includes the individuals on the ground. When they're happy, the service quality goes up. Let's prepare to discuss this at the meeting as well.
