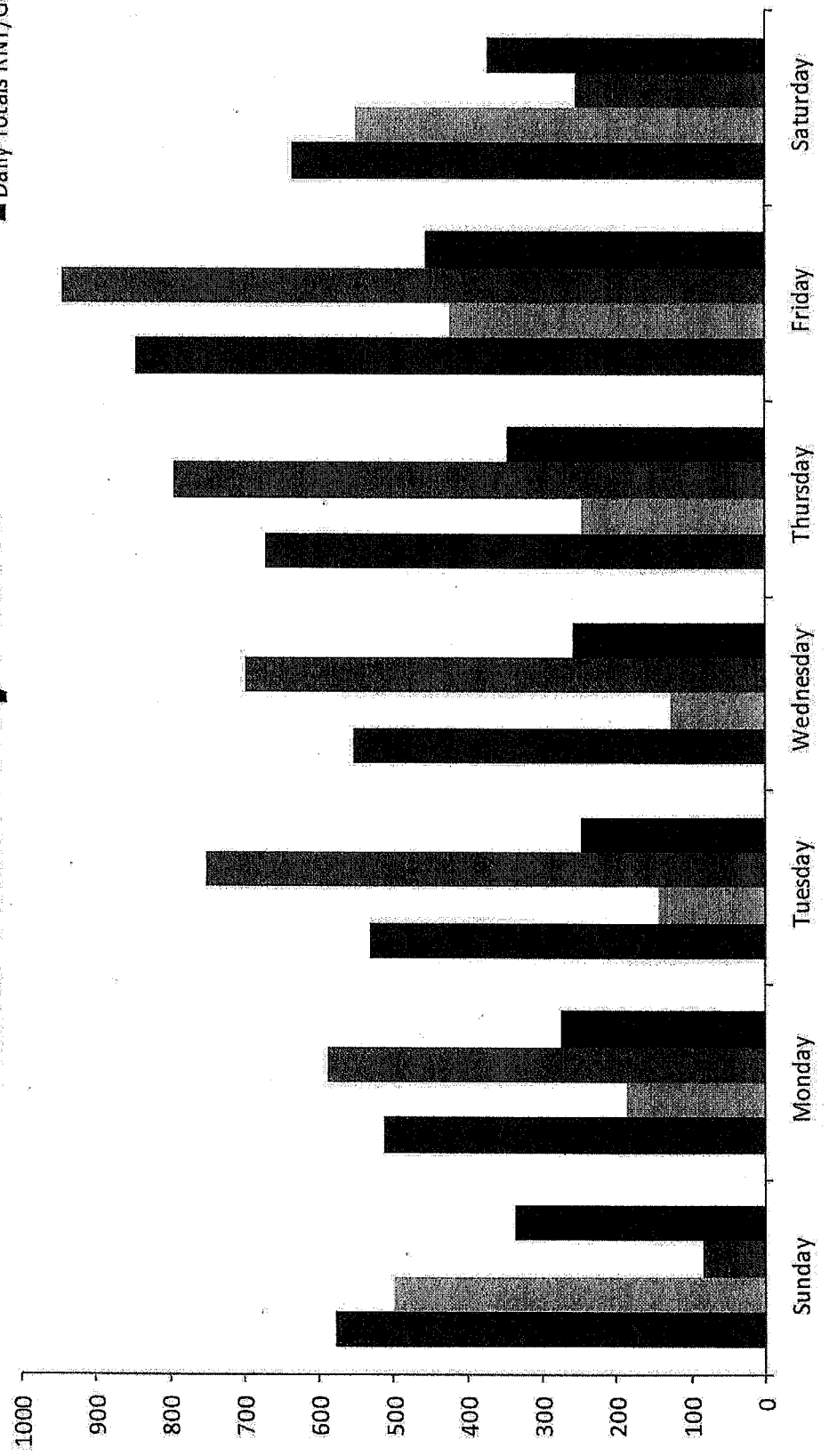

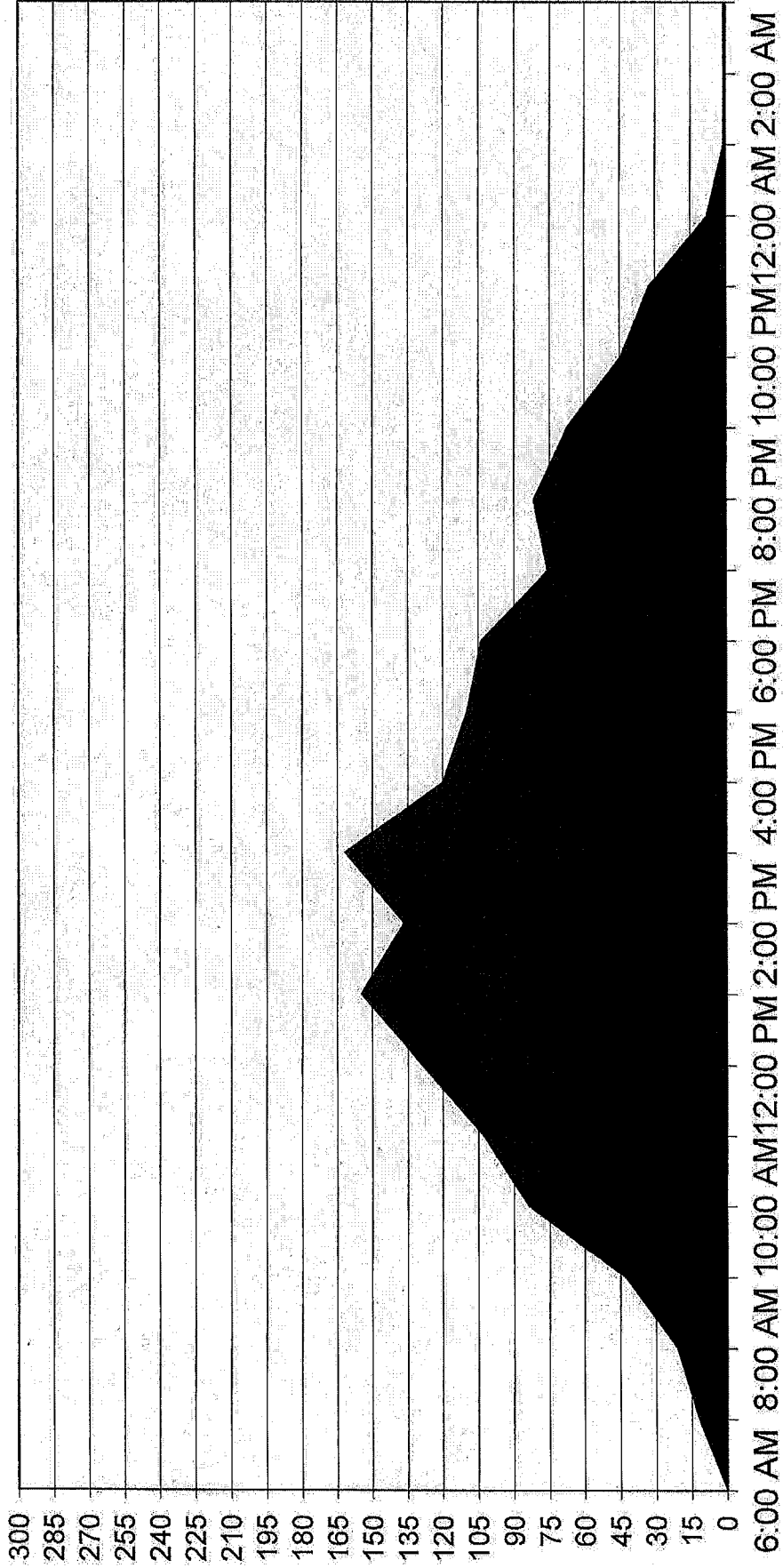

AROUND 02:20 I S/O JAMES EBANY WAS MONITORING THE GATE WHEN A UBER CAR PULL UP TO THE GATE HE WAS GOING TO 295. THE UBER CAR WAS NOT LISTED THERE. I CONTACTED THE RENTER AND GOT NO ANSWER I LEFT A MESSAGE. AT THIS TIME THE UBER DRIVER CONTACTED THE PERSON HE WAS PICKING UP. IT WAS A DAVE BARTHOLOMEW. HE IS LISTED AS A TEMP GUEST FOR 295. THE UBER DRIVER PUT HIM ON THE SPEAKER PHONE FROM HIS PHONE. I TOLD MR. BARTHOLOMEW "THAT HE NEEDS TO CALL THE GATE, I CAN'T TAKE CALLS OVER THE CELL PHONE." HE THEN KEPT GIVING HIS NAME TO ME. I EXPLAINED TO HIM A COUPLE MORE TIMES TO CALL THE GATE HE COULD BARLEY TALK TO ME. HE SOUNDED LIKE HE WAS INTOXICATED. HE THEN STARTED YELLING AND SCREAMING USING VULGAR LANGUAGE AT ME. HE THEN THERTENDED ME SAYING "IF I CROSS YOU ON MY WAY WALKING OUT, I MIGHT DO SOMETHING TO YOU." I ENDED THE CONVERSATION WRIGHT THERE. I WAITED FOR CALL AT GATE FROM 295. I NEVER GOT ONE. I THEN CONTACTED THE RENTER ONE MORE TIME AND SPOKE A ANDREA STARK 949-274-0015. I EXPLAINED THE SITUATION TO HER. SHE IS LISTED AS A RENTER ON THAT ADDRESS. SHE OK'D THE UBER TO COME IN. 
