## 6. SECURITY

## **Monthly Securitas Report for August 2018:**

a. Securitas Post Commander Robert Stabenow reported an EMS call and a car accident involving a fire hydrant (no damage to the hydrant). New Patrol Officer has been hired and the Traverse method of patrolling the road is in place. Board has asked that Securitas use the radar guns and track speeders with names and addresses to create a monthly report.

The board requested Securitas to NOT allow access for party rental trucks and party bus companies to those homes that are being used for short-term vacation rentals.

Director Muller talked about speeding vehicles and suggested the District look into some type of portable speed control device/electric signboard, that, when placed in the rear of the patrol vehicle could show the speed of the oncoming car in bright flashing lights.

# b. Short Term Rentals Q&A with SeaBreeze Vacation Rentals

SeaBreeze Vacation Rental Co. owner, Jeff Bosson spoke about his company and the complaints from homeowners about STR's. A lot of back and forth with regards to problems with noise, garbage, disrespectful renters, too many cars and over-occupancy. It was agreed this is a problem that needs to be addressed and the topic will be placed on next month's agenda. Mr. Bosson stated he would sit down with District staff this week to develop some solutions. The Board agreed to have District Counsel review the Government Code for Special Districts to find out if the District has any legal ability to set limits on STR activity, such as number of vehicles or number of guests
