



They said that earlier they had guests outside but complied in keeping their noise level down. 10:41: I informed patrol of the calls made to the houses and to have a last check of the area before resuming duties. * No futher complaints/calls received from 35-621.

Around 1500, I returned to the flooded area and noticed water is an inch or so away from the engine bay of unit #35351's white Rolls Royce so I decided to reassess situation and take action. I took a shovel and problem for now. Flooding has gone down and drain is functioning as it should. Did final clean up on all loose debris. End of report.
