Manager Russell explained that the super high tides that the community experienced over the Fourth of July weekend were the result of a combination of the full-moon lunar effect on the high tides plus a strong tidal surge and ocean swell from a tropical influence in the southern hemisphere. The District will be keeping a close watch from now on for tropical cyclone activity that develops in the warm equatorial waters off the coasts of Mexico and Central America that could generate a strong south swell to our shores.
