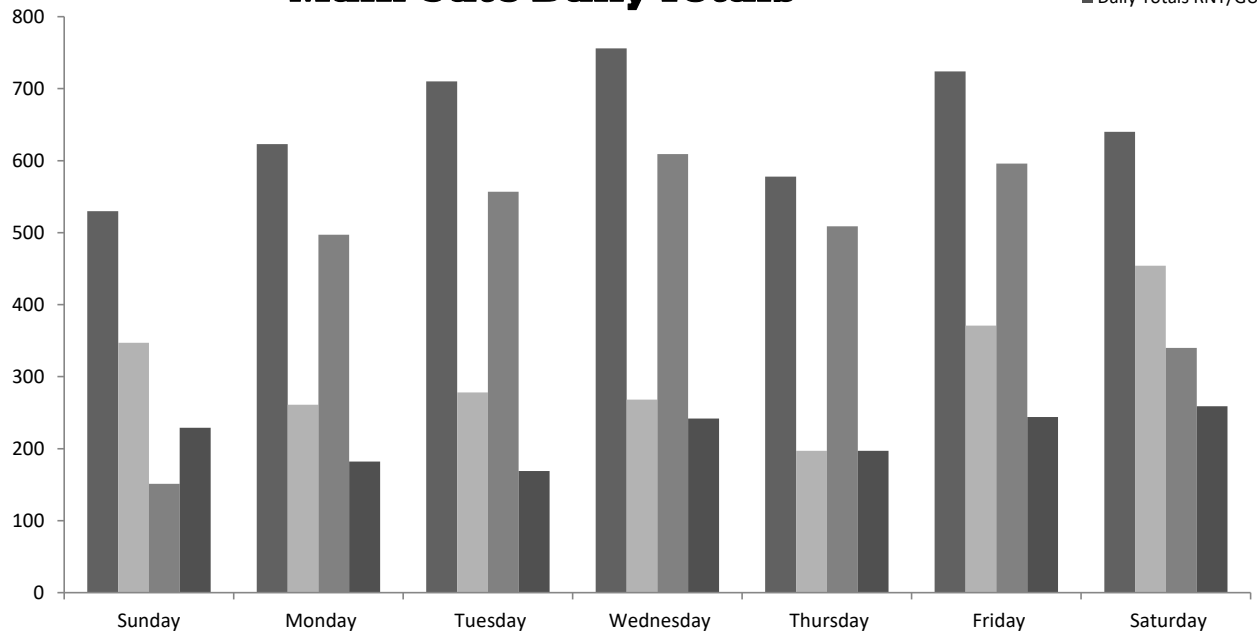

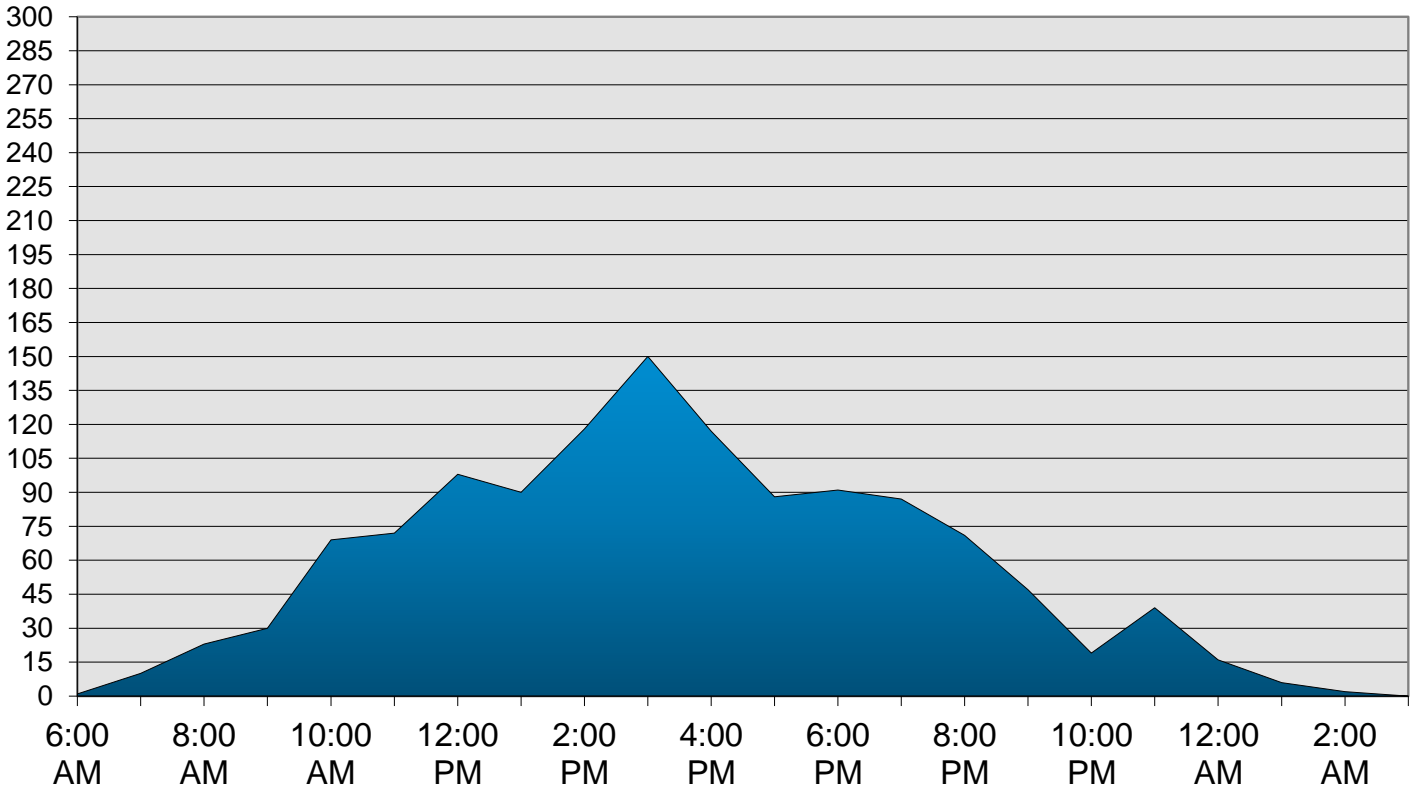

THE RENTAL PROPERTY HAS A VEHICLES LIMIT OF 2 VEHICLES PER RENTER AND THERE WAS A 3RD VEHICLE PARKED AT THE PROPERTY. A VOICEMAIL MESSAGE WAS LEFT ON SEABREEZE'S MAIN LINE. NOTHING FURHTER TO REPORT.
5/31/2021	15:05	GUEST GATE ARM BROKEN	0845	GATE	N	IN BETWEEN THE TIME WINDOW OF 3:05PM - 3:07PM, RESIDENT FROM 845 WAS DRIVING A "LIFTED" TRUCK, AND HE WENT THROUGH THE GUEST GATE WITHOUT SEEING IT--OR SO IT SEEMED. HE SEEMED TO HAVE GROWN IMPATIENT AFTER ONLY WAITING ABOUT 2 MINS OR LESS WHILE I WAS TRYING TO CONVERSE WITH AN INEBRITAED INDIVIDUAL OVER THE PHONE. THE RESIDENT HAD CLAIMED THAT I WAS MESSING AROUND OVER THE PHONE WITH THE LONG TERM RETNER, AND TRIED TO JUSTIFY THAT AS THE REASON FOR BREAKING THE GATE ARM--AS OPPOSED TO HIS IMPATIENCE GETTING THE BEST OF HIM. I TRIED TO DE-ESCALATE THE SITUATION BY NOTIFYING HIM THAT HE SHOULD APPLY FOR A TRANSPONDER TO AVOID INCIDENTS OF THIS KIND. HE SAID HE WOULD GIVE ME A CALL ONCE HE WAS AT HOME. AS FINAL OBSERVATION TO NOTE, HE SEEMED APOLOGETIC AND EMBARRASSED MORE SO THAN AN INNATE FRUSTRATION OR ANGER--WHICH MAKES ME BELIEVE THAT IT WAS INDEED AN ACCIDENT, RATHER THAN THE ENITRE OCCURRENCE HAVING SOME KIND OF ILL-INTENT.

SHE DROVE A BLUE MINI COOPER AND I ALSO WITNESSED HER HARASSING THE ANIMAL IN THE BACK SEAT FIRSHAND. (THE CAMERA AT THE FRONT GATE MIGHT'VE CAPTURED THE INCIDENT; TIME STMAP: APPROX. 3:25PM.) I THEN PROCEEDED TO CALL SHERIFF DISPATCH AND BY 3:30PM I SPOKE TO AN OFFICER IN PERSON WITH ALL THE PERTAINING DETAILS. BY THE TIME THE OFFICER ARRIVED THE WOMAN HAD LEFT THE PUBLIC LOT. THE POLICE OFFICER LEFT AROUND 4PM HAVING FOUND A POTENTIAL LEAD AS TO HER WHERE ABOUTS, BUT CALLED ME ABOUT 20MINS LATER THAT SHE WAS, "IN THE WIND". NOTHING FURTHER TO REPORT.

I ATTEMPTED TO CONTACT BOTH LISTED HOMEOWNERS, AFTER SEVERAL ATTEMPTS, CALLS STARTED TO GET FORWARD TO VOICEMAIL. THE GUESTS TRIED TO CONTACT HOMEOWNERS AS WELL WITH NO SUCCESS. AT APPROX 2317HRS "BILL MELDIN" TOLD ME 'HE DIDN'T CARE AND WAS GOING IN REGARDLESS'. I PROCEEDED TO TELL HIM HE WAS TRESSPASSING AND DISPATCHED PATROL 1.
