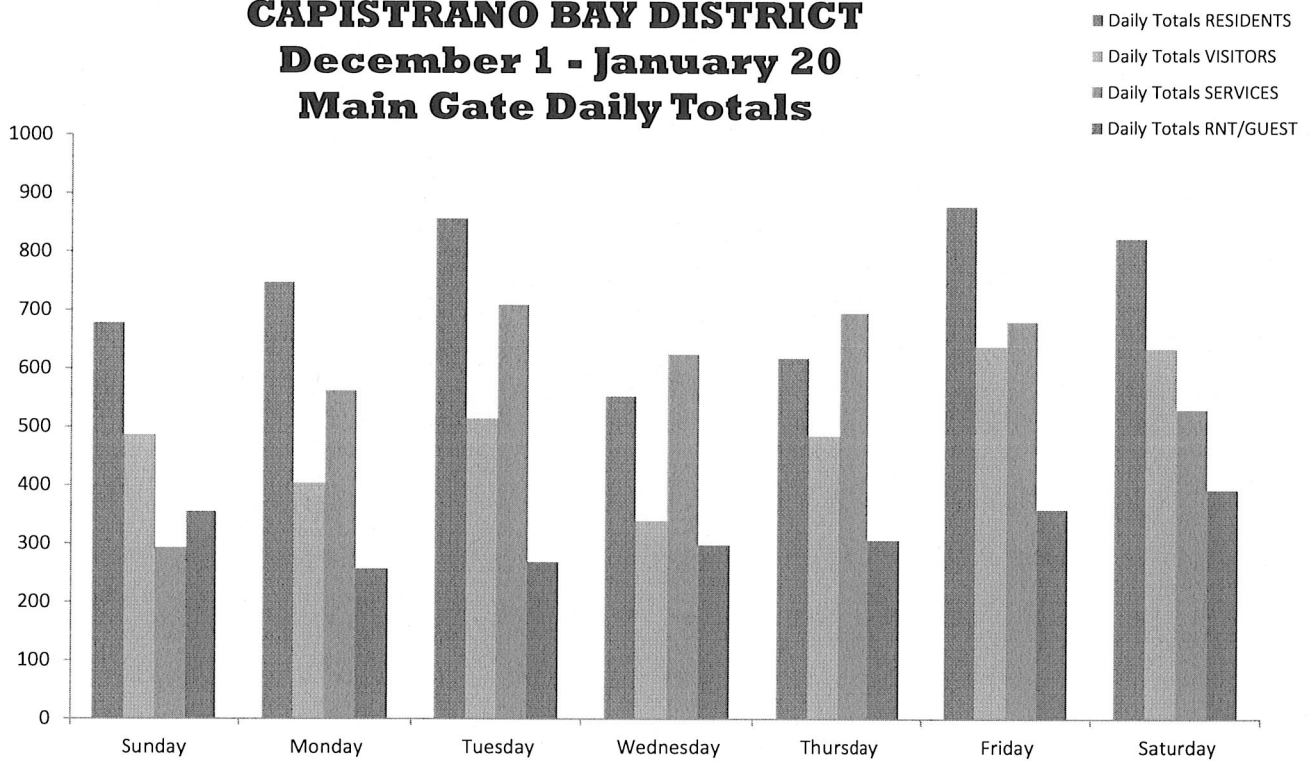

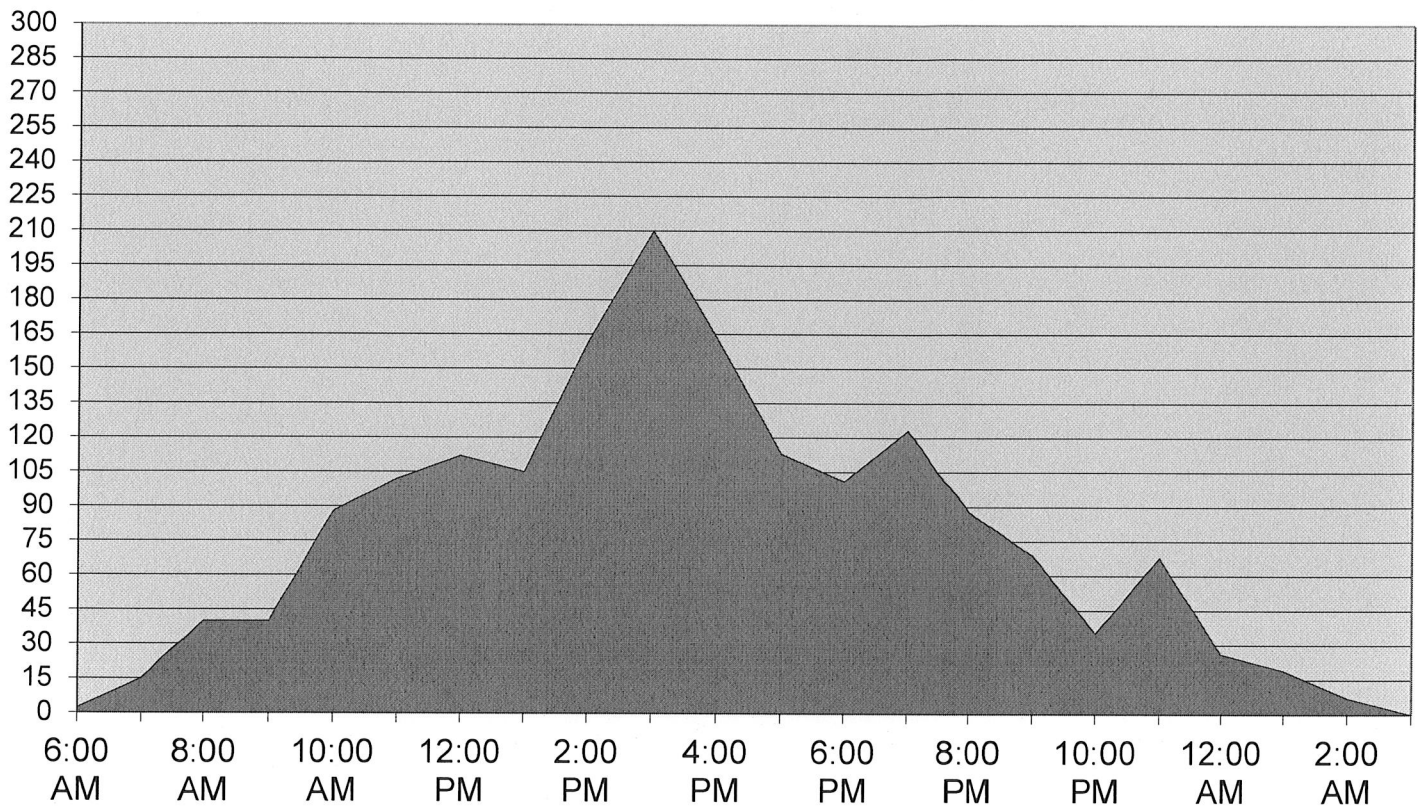

12-10-21	15:04	SEABREEZE RENTER ISSUES	0/095	PC / GATE	N	FEMALE RENTER FROM 095 PULLED UP TO THE GATE AND STARTED COUSING A SCENE BECOUSE WE WOULD NOT ALLOW HER GUEST ENTRY. SHE THEN BEGAN RECORDING US AND DEMANDING OUR NAMES AS WELL AS THREATINING TO CALL THE POLICE FOR NOT ALLOWING HER TO HAVE ACESS TO HER PROPERTY. I CALMLY EXPLAINED THE RULES OF THE ROAD AND THE ORDENANCES WE FOLLOW. SHE LEFT AFTER TRYING TO INCRIMINATE US THREW SELECTIVE QUESTIONING WHILE FILMING. AFTER A FEW HOURES THE MAIN RENTER MALE OF 095 PULLED UP TO THE GATE AND FLASHED HIS P.D.
