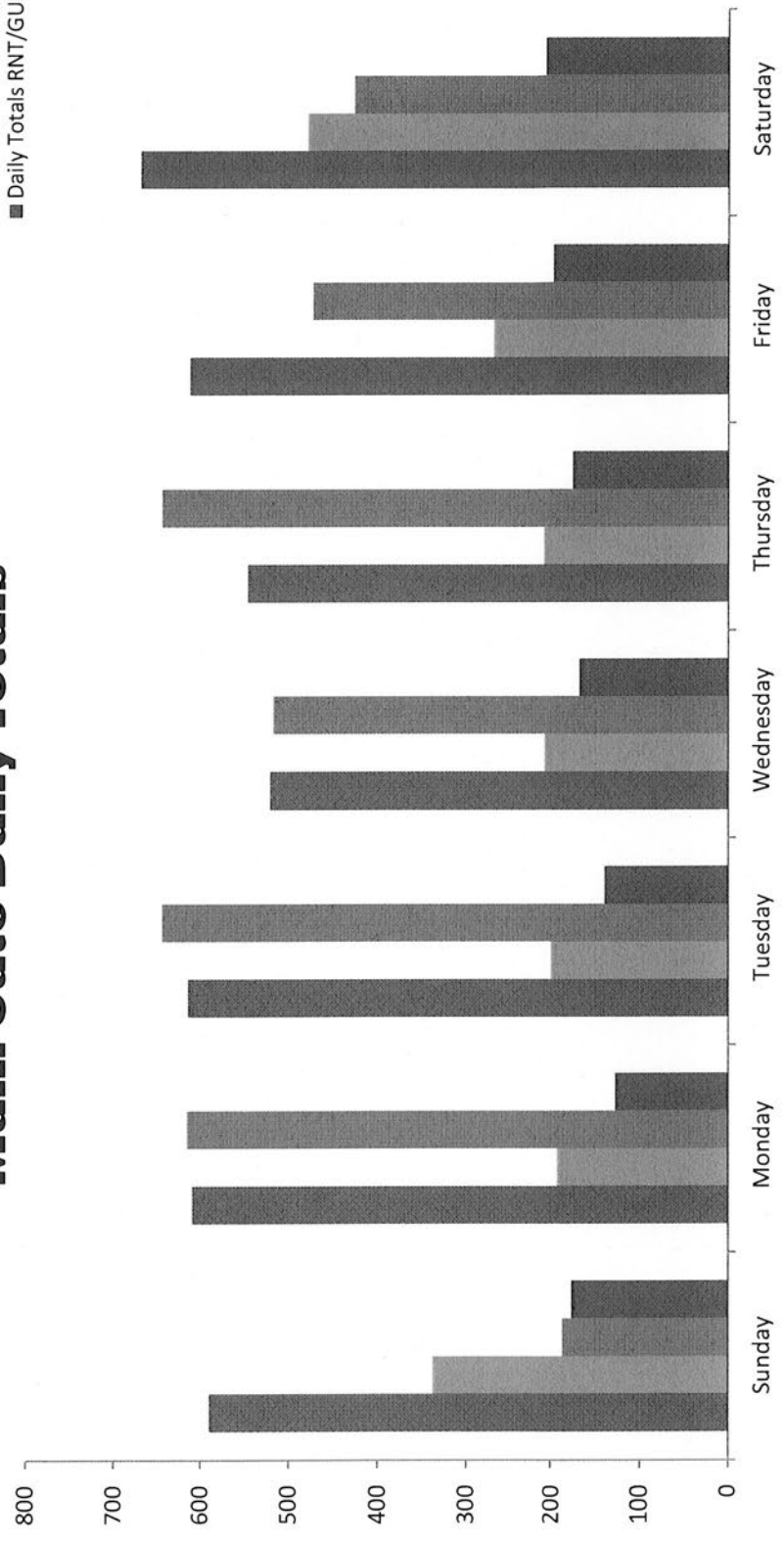

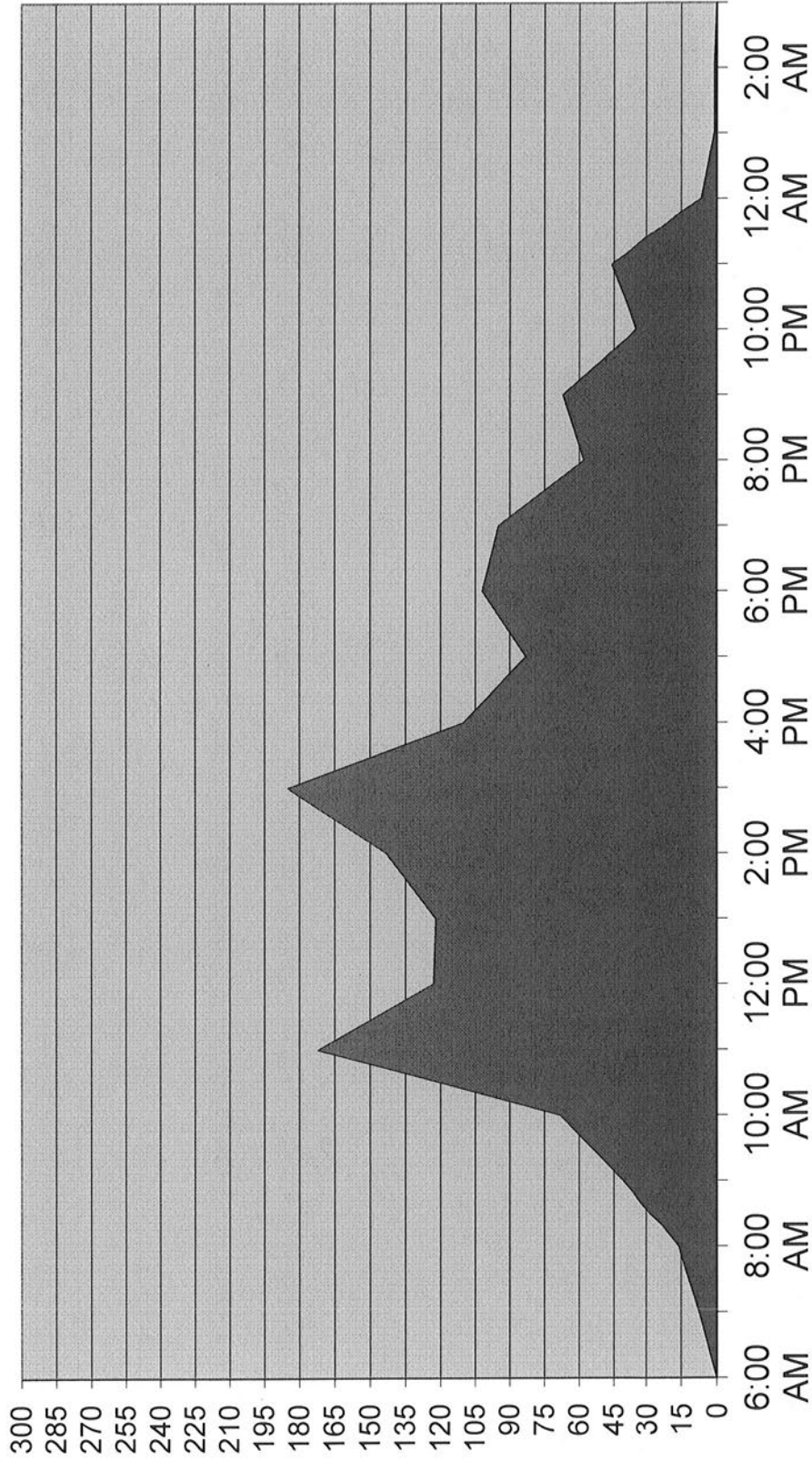

I FOLLOWED HIM UNTIL HE NO LONGER WAS NEAR THE COMMUNITY.

I ASKED FOR A BRIEF DESCRIPTION AND THE FOLLOWING WAS GIVEN TO ME: MALE, 6'2", LATE 40'S, AFRICAN AMERICAN, WITH TWO HANDBAGS. WITH THIS, I DISPATCHED PATROL 1 TO THE SITE LAST SEEN WHICH WAS 155. PATROL MADE VISUAL, AND AFTER TRYING TO PERSUADE THE TRANSIENT MALE TO VACATE THE PREMISES, PATROL 1 REQUESTED THAT I CALL THE POLICE BECAUSE THE TRESPASSER WAS NOT COOPERATING. AT 8:12 PM I CONTACTED THE POLICE, GAVE THEM ALL OF THE INFORMATION I OBTAINED, AND BY 8:24 PM, 2 PD UNITS REPORTED TO THE GATE. PD MADE CONTACT WITH THE PERSON WHO WOULD NOT LISTEN TO THEM AT FIRST BUT WHEN THREATENED HE BEGAN TO CO-OPERATE. AFTER BEING SEARCHED THE PD MADE PATROL GIVE A RIDE TO THE INDIVIDUAL AND ESCORT HIM OUT OF THE PROPERTY.
