



BASED ON THE BEHAVIOR, AND MY OBSERVATIONS, I COULD TELL THAT THE UBER WAS NOT AN UBER SINCE WE HAD A SIMILAR OCCURRENCE WITH A WHITE MINI COOPER EARLIER CLAIMING SHE WAS AN "UBER" ALSO. I NOTIFIED THE PROPERTY MANAGER FOR 201 M. STANITSAS ABOUT THE INTERACTION, AND FOLLOWED UP WITH PATROL FOR A VEHICLE COUNT. SURE ENOUGH, THE "UBER" WHICH WAS A RED CONVERTIBLE MUSTANG, WAS ON SITE WITHOUT A RENTER PASS OR REGISTRATION WHICH PROVED THAT THE RENTER WAS NOT GETTING DROPPED OFF, AND THAT THE UBER WAS NOT AN UBER BUT A GUEST WHO DIDN'T FOLLOW PROPER PROTOCOL TO ENTER THE COMMUNITY. PATROL CONFIRMED THE VEHICLE AND CITED IT ACCORDINGLY. NOTHING FURTHER TO REPORT.

4/10/2022	22:16	TRESPASS	835	GATE / PATROL 1 / PATROL 2	Y	GOT A CALL FROM A HOMEOWNER ABOUT A MAN SLEEPING UNDER 38835. THE MAN WAS UNCO-OPERATIVE WITH BOTH PATROL 1/2. THE PD WAS CALLED AND THEY DISPATCHED TWO UNITS WHO EVENTUALLY GOT THE MAN TO LEAVE OUR PROPERTY.
4/16/2022	18:10	AFTER HOUR WORKERS	555/211	GATE / PATROL 1 / PATROL 2	N	AT 1810, A WHITE PICKUP TRUCK WITH WORKERS ARRIVED AT THE GATE REQUESTING ACCESS. I INITIALLY DENIED ACCESS DUE TO WORKING HOURS ENDING AT 1400. THE WORKERS THEN TOLD ME THAT THEY ARE JUST GOING TO PICK UP SOME TOOLS AND THAT THEY ARE LEAVING IMMEDIATELY. I MADE THE COMPROMISE OF ASKING ONE OF THE WORKERS TO LEAVE A FORM OF IDENTIFICATION WITH ME AT THE GATE WHILE THEY PICK UP THEIR TOOLS AND THEY CAN PICK UP THE ID ON THEIR WAY OUT. ONE OF THE WORKERS LEFT ME HIS CONSULAR ID AND I LET THEM IN TEMPORARILY. AT 1816, I RECIEVE A PHONE CALL FROMTHE RESIDENT OF 555, AND INQUIRED AS TO WHY I TOOK ONE OF HIS WORKERS' ID. I THEN INFORMED HIM THAT THEY ARE NOT ALLOWED TO BE IN THE COMMUNITY TO BEGIN WITH BUT I DID THE WORKERS A FAVOR BY ALLOWING THEM TEMPORARY ACCESS TO PICK UP THEIR TOOLS IN EXCHANGE FOR AN ID WHICH SERVES AS COLLATERAL. HE THEN TOLD ME THAT HE IS CALLING IN THE WORKERS AS HIS GUESTS FROM TODAY ALL THE WAY TO MONDAY. THE WORKERS THEN CAME BACK TO THE FRONT GATE AND I CHECKED THEM IN AS GUESTS AND I RETURNED THE CONSULAR ID. AT 1927,

			PATROL 1 CALLS ME OVER THE RADIO AND INFORMS ME THAT A RESIDENT FROM #35557 INFORMED HIM THAT THEY CAN HEAR SOME NOISE COMING FROM #35555. HE ALSO SAID THAT THE NOISE RESEMBLED A POWER TOOL LIKE A SANDER OR A GRINDER. I THEN TOLD PATROL 1 TO HEAD TO #35555 AND INVESTIGATE THE SITUATION. AT 1931, PATROL 1 CALLS ME AGAIN AND CONFIRMS THAT THERE IS CONSTRUCTION WORK GOING ON AT #35555. I THEN TOLD PATROL 1 TO ADVISE THE WORKERS THAT WORK IS NOT ALLOWED AT THE MOMENT AND THEY HAVE TO STOP ALL WORK UNTILL MONDAY. THEY AGREED AND THAT NO MORE WORK WOULD BE DONE. WE GOT ANOTHER CALL FROM A RESIDENT ABOUT TWO PEOPLE FISHING BEHIND 211. IT WAS THE SAME TWO WORKER FROM 555 AFTER TELLING THEM THEY HAD TO STOP AND GO BACK TO THIER OUN PROPERTY. TTHEY GOT MAD AND DEMANDED WE CALL THE HOMEOWNER OF 555. I CALLED THE HOMEOWNER OF 555 AND INFORMED HIM ABOUT WHAT WAS GOING ON AND OUR RULES / REGULATIONS FOR THE COMMUNITY. THE HOME OWNER WAS FRUSTRATED AND ASKED US TO HAVE THEM LEAVE THE PROPERTY. AT 1736, PATROL 1 INFORMS ME THAT THE WORKERS HAVE LEFT THE COMMUNITY. NOTHING FURTHER TO REPORT.
