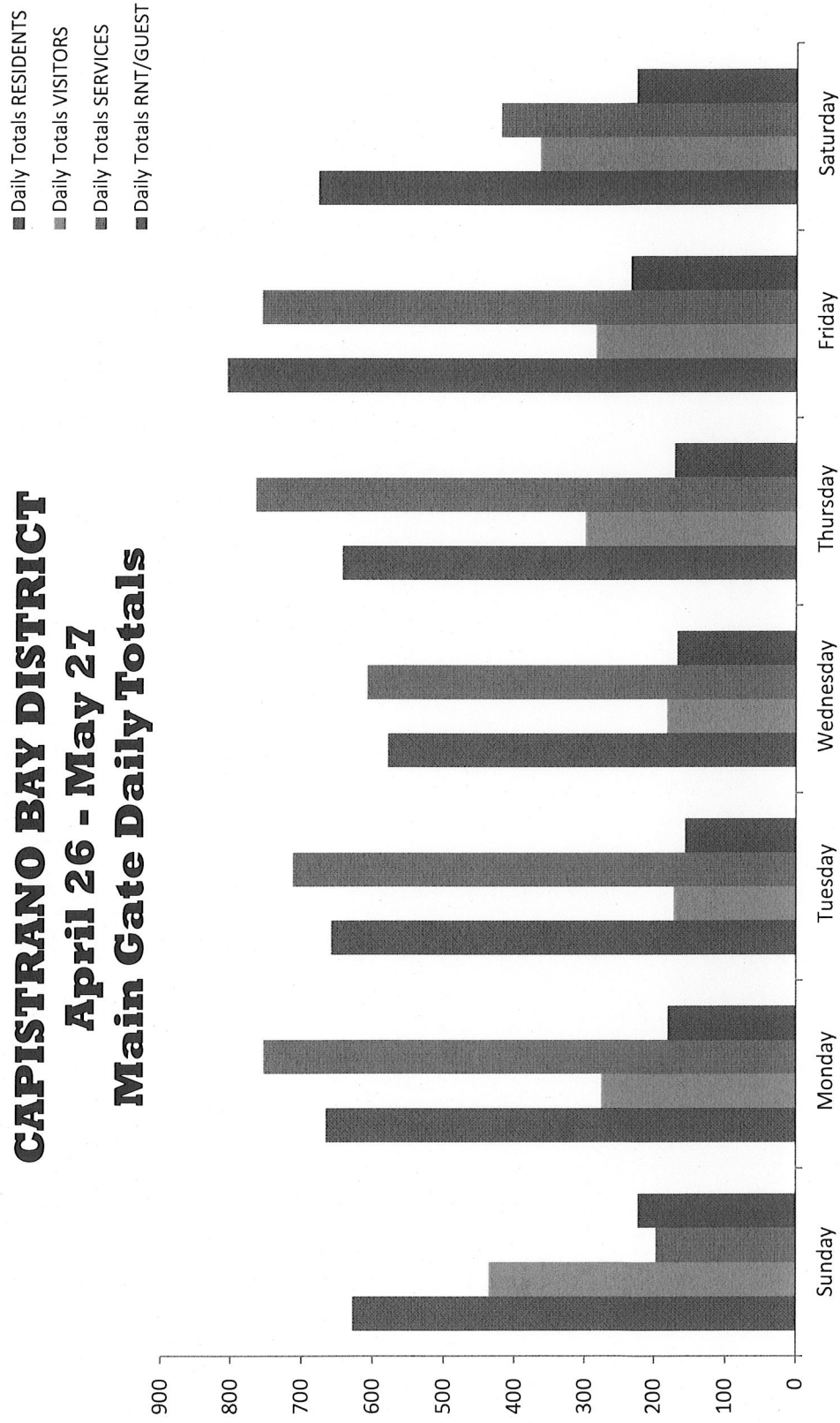

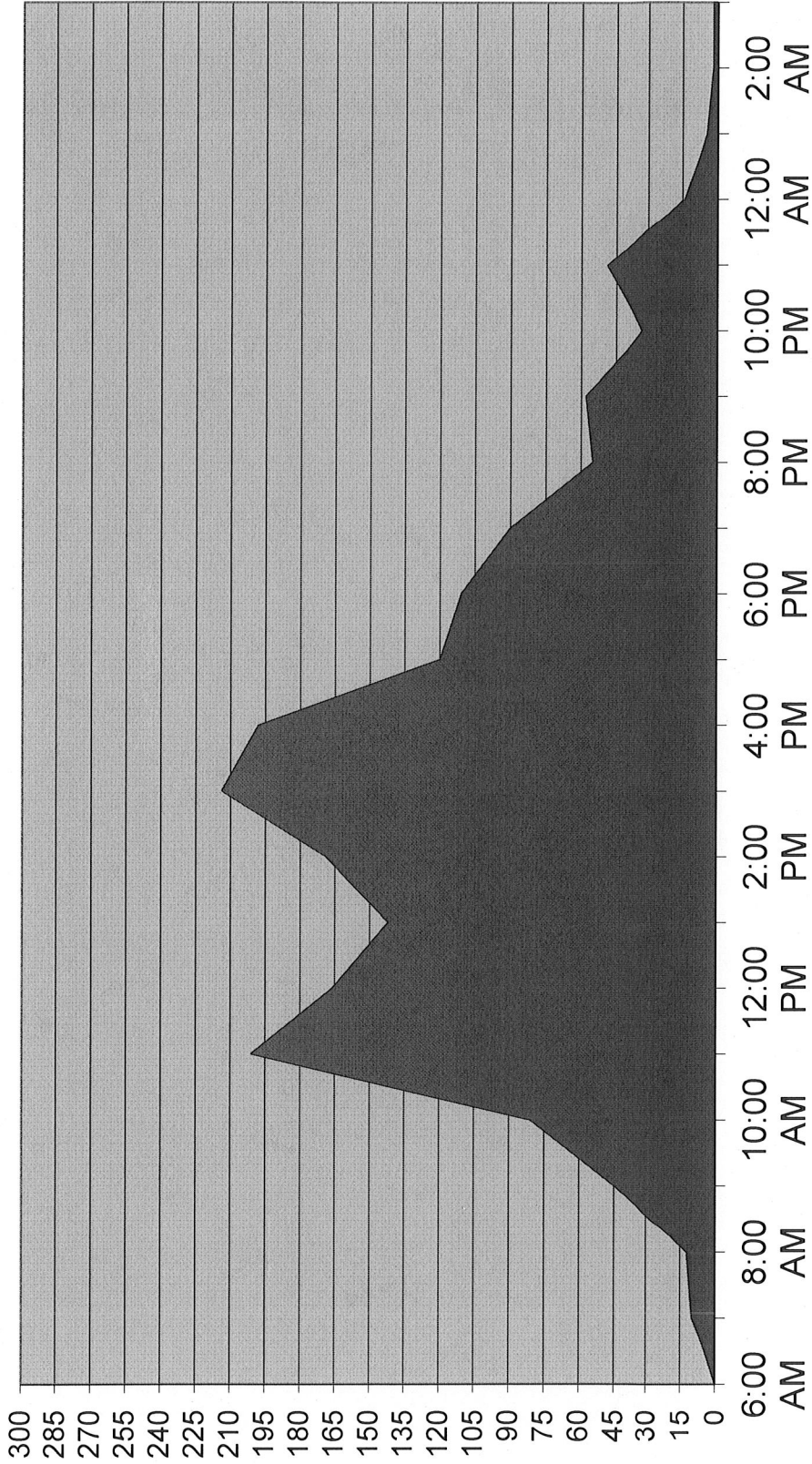

Music was playing through a speaker however I did not see the described flashing lights at this time. I spoke with the main renter of 35-391, notified him of the complaint and reiterated the quiet hour rules. The renters agreed to keep the noise level down. They shut off the music and said they were about to return inside their property shortly. I updated the front gate officer and departed the property at approximately 0007 hours.
