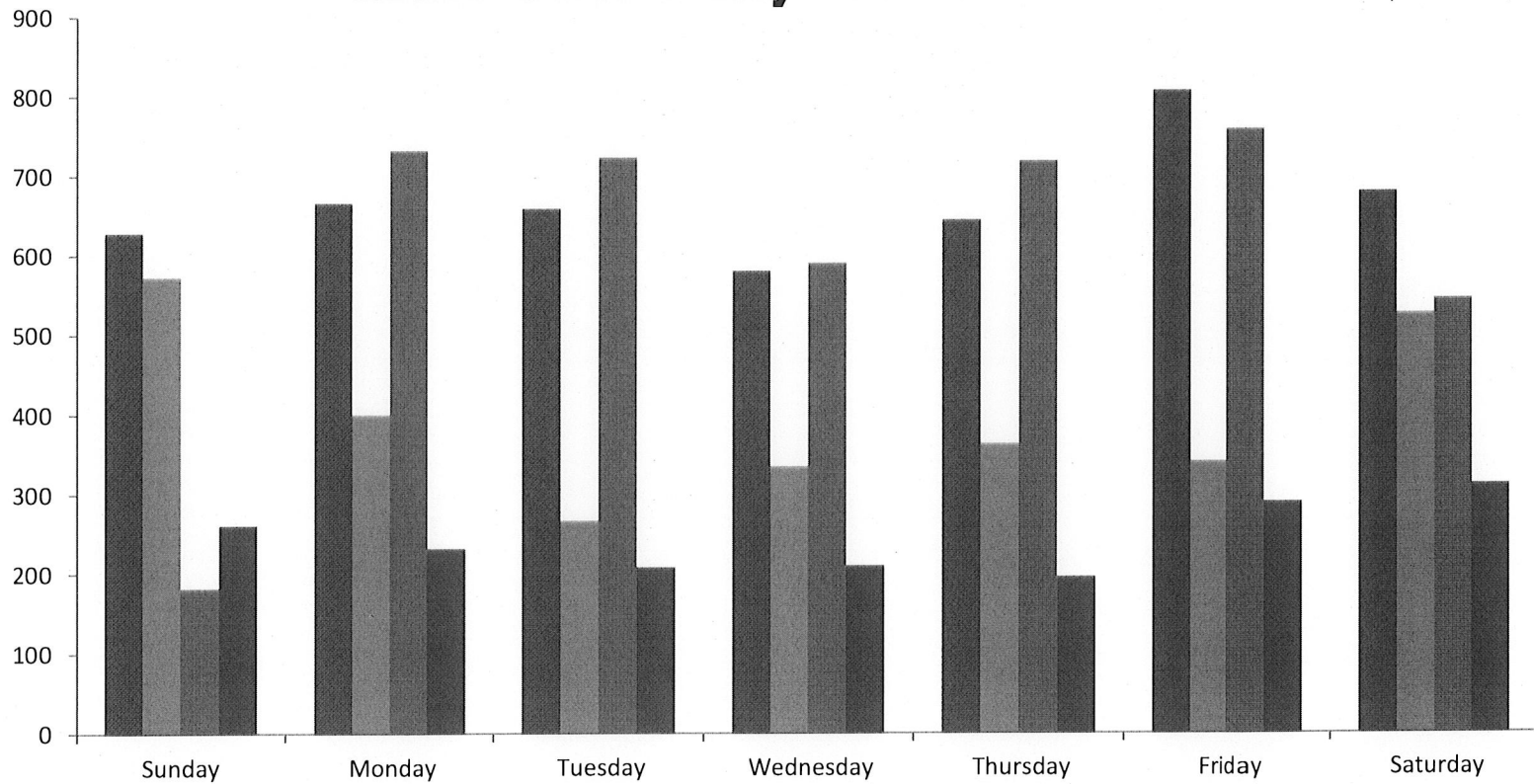

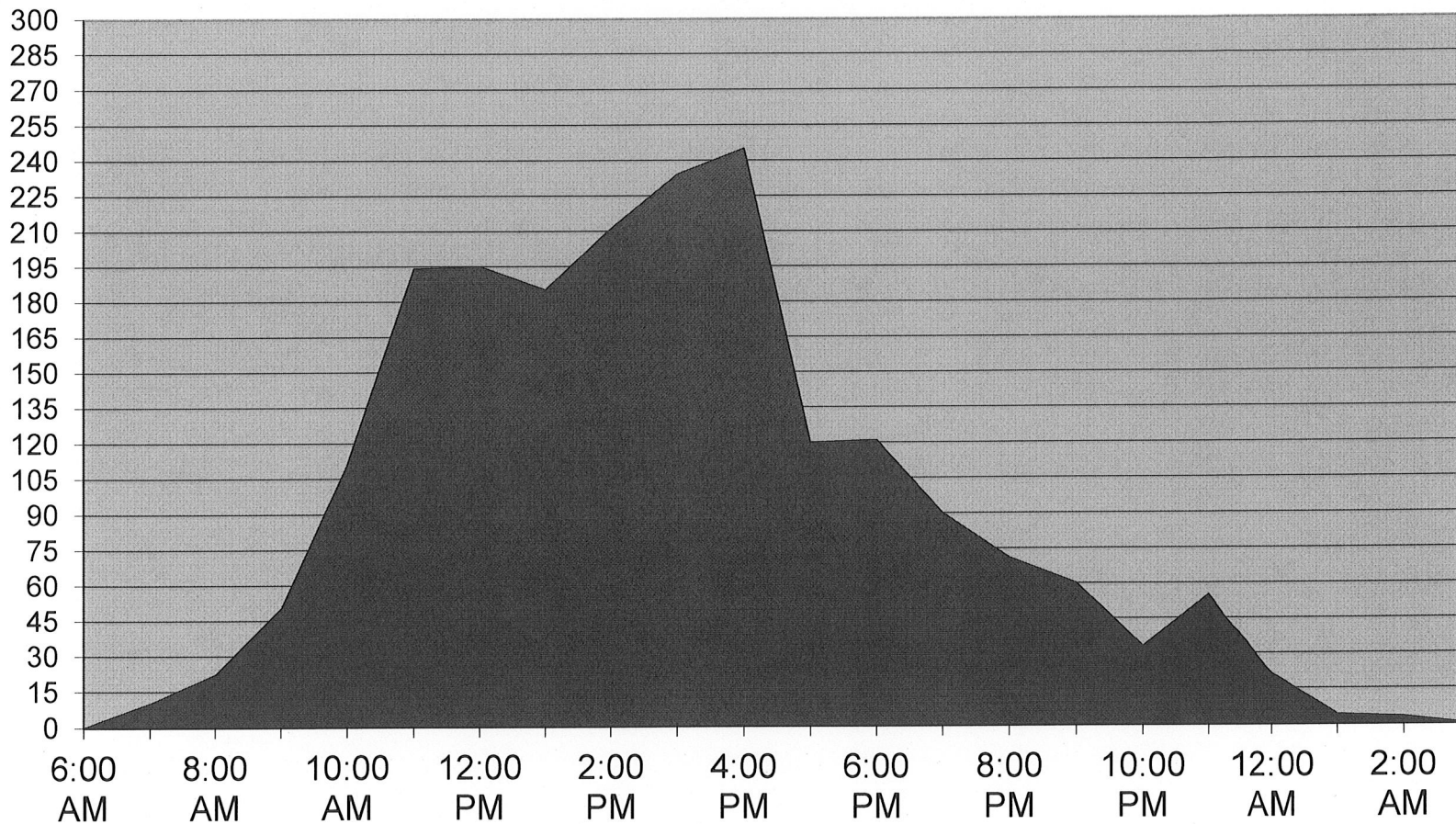

AS I APPROACHED THE GENTLEMEN TO ASK IF HE COULD MOVE OFF TO THE SIDE WITH ME AND EXPLAIN WHY HE WAS UPSET. HE REFUSED AND BEGAN SHOUTING AT ME. HE WAS MAD BECAUSE HE WAS ON THE EMPTY LOT LAST NOT NEAR THE END OF THE ROAD BUTWAS FORCED TO LEAVE BY THE GUARD FOR TRESPASSING, AND THAT HE WOULD NOT OPEN THE GATE AND LET HIM ONTO THE ROAD FORCING HIM TO WALK OUT INTO HIGH TIDE.
