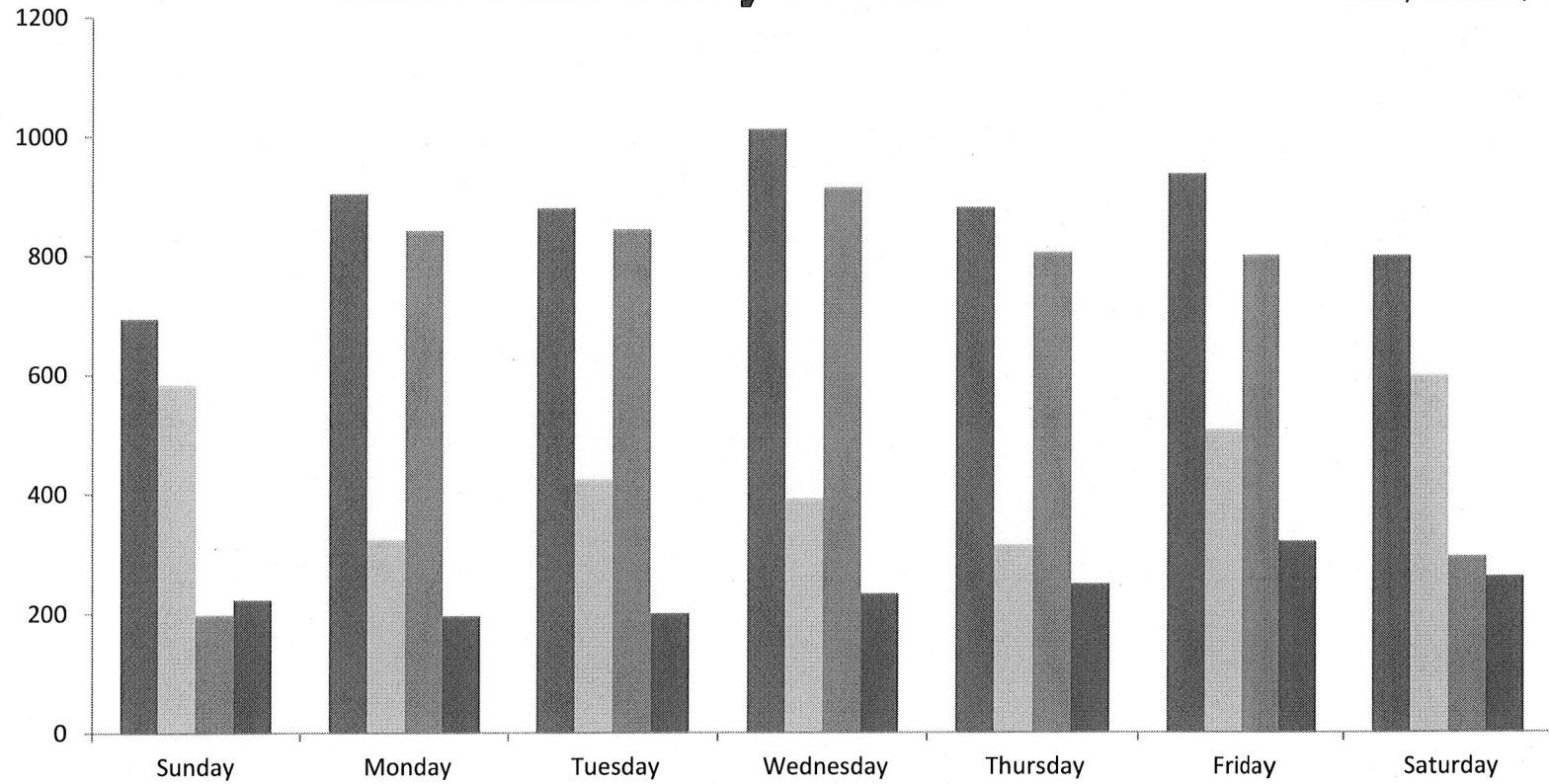

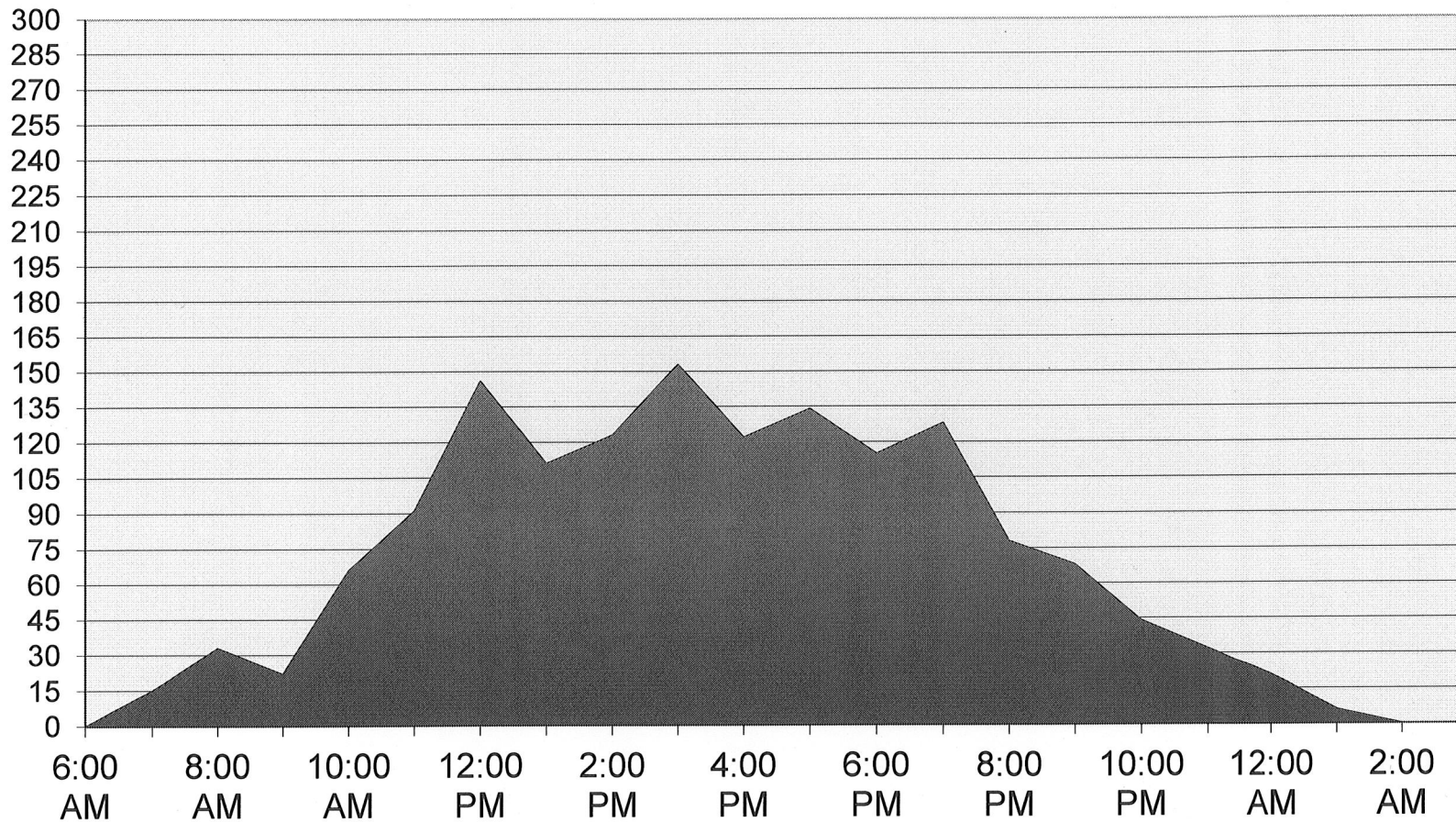

AT 0128 PATROL REPORTED HAVING MADE CONTACT AND WAS IN THE PROCESS OF ESCORTING THE TRESPASSER OUT. AT 0158 HOURS PATROL REPORTED THAT THE TRESPASSER HAD LEFT THE DISTRICT VIA THE 800 BLOCK.

I DID SO AROUND 00:25. A TECHNICIAN SHOWED UP AROUND 00:40 AND CHECKED OUT THE SITUATION AND DETERMINED A FEW TRANSFORMERS BLEW OUT AND THAT A WORK CREW WILL BE SHOWING UP LATER. 00:40. CREW SHOWED UP AT 0200 TO FIX ISSUE AT 600 BLOCK. CREW LEFT AT 0530.

PATROL ASKED ME TO CONTACT 235 TO LET THEIR KID KNOW NOT TO ENTER 241'S PROPERTY. AND THEN CONTACT 241 TO LET THEM KNOW THAT WE HAVE INVESTIGATED.
