Police Activity/March-April

The District is now in receipt of our traffic ticket citation books. Before Officer Williams can begin issuing speeding tickets, a matter has come up regarding Officer Williams POST certification. Apparently POST does not have his qualification certificates on file and this is being addressed right now. This matter is expected to be concluded in the next two weeks. In the meantime, Officer Williams will continue to run radar and intervene with violators.

POSTED SPEED LIMIT 15 MPH

Just so you are aware, according to the OC Superior Court Uniform Bail Schedule, the total bail amount for speeding on Beach Road will be as follows:

|----------------------------------|-------|---------------------|
| - 1-15 MPH over the speed limit | \$228 | (up to 30 MPH) |
| - 16-25 MPH over the speed limit | 352 | (31 to 40 MPH) |
| - 26 MPH and greater | 470 | (41 MPH or greater) |

Bail amounts are paid to the Court by the violator and the Court remits a portion of that back to the agency issuing the citation. Amounts remitted to the District will go into a fund for police operations.
