1. CALL TO ORDER

4. PRESENTATION/SPECIAL TAX LEVY/CALL TO ORDER ELECTION

a. Approval of Resolution No. 9-5-23, calling for an election date of December 19, 2023, and including the draft language for the Ordinance to be approved in December if the measure passes in the voting.

MOTION was made by Director Jenkins, seconded by Director Misher and passed by a vote of 3-0-2 to approve Resolution No. 9-5-23, setting the date of the parcel tax election for December 19, 2023.

5. ADVISORY COMMITTEE

a. After-the-fact (ATF) Permit and Casa Mira Ruling Manager Russell explained that the Committee is continuing to educate the ATF candidate and expects to complete the agreement in the following two weeks whereby the Committee can move forward with the CDP application process with the City.

In the Casa Mira ruling, the CCC has recently began ruling on Coastal Development Permits that an 'existing structure' refers only to homes built prior to January 1977 (when the Coastal Act passed into law). This is a complete reversal of the CCC original interpretation that meant any house or structure that is in existence at the time an owner applies for a permit. The Superior Court in San Mateo ruled that 'existing' means just what it says; existing at the time an owner applies for a CDP. It is expected that the CCC will appeal which would push any final ruling out at least two more years.

6. <u>APPROVAL OF MINUTES</u>

a. Meeting #697 of August 1, 2023

<u>Motion</u> was made by Director Misher, seconded by Director Jenkins and approved by a vote of 3-0-2, to accept the minutes of August 1, 2023, as presented.

7. <u>SECURITY</u>

a. Monthly Security/Police Report – July/August 2023

Security Supervisor Stabenow reported on two incidents of trespassers being apprehended and escorted out of the community. Also one incident of the renters in the lower unit of a rental complained about the late night noise of the renters upstairs – turned out that they were all the same group just not getting along with each other.

Manager Russell reported that our police officer is now issuing speeding citations since completing his POST requalification training. Cites have been issued to two different guests, both going above 30 mph and one with a very bad attitude. Cites are processed through OC Superior Court and fines start at \$420.

a. Monthly Expense Report

The expense report through July 2023 was received and filed with no discussion.

b. FY24 Budget

While the income budget for FY24 was approved at the June Board meeting, the expense side of the budget has been postponed to a meeting scheduled for Wednesday, September 13th at 10:00 AM.

11. QUALITY OF LIFE - CBRA DISCUSSION ITEMS
