Directors' Terms Expiring in December

Citing personal family reasons, Director Will Wiersig has submitted a resignation letter indicating he has chosen to step down from his directorship duties, the term of which expires in December 2024.

Additionally in December, the term of Director Brad Jenkins expires. As was explained in the report at the last Board meeting, outgoing Directors choosing to sit for another term are not automatically entitled to the position and must go through the election process along with any other candidates.

Director Jenkins has expressed his interest in running for a second term, therefore his name will be submitted to the OC Registrar of Voters in August along with any other interested candidates.

As for the immediate opening on the Board, the District must fill the position as soon as possible to maintain a five-member Board.

Fortunately, the District has received memos of interest from two property owners who are willing to accept the directorship through the end of December when Director Wiersig's term is to expire:
