Nails and Screws/Security Directive

Security has been issued a Directive for construction site inspections to commence immediately. This will require all patrol officers to make an aggressive effort during each shift to stop and inspect the roadway and the edge of the work site near the road for nails, screws, and any sharp objects that can get tracked onto the road. This will also include careful inspections under work trucks and vehicles in the RR parking area.

Penalties for repeat issues at any particular work site can result in workers being banned from access into the community for a day or more depending on their cooperation and demonstration of making a visible effort to clean up the roadway after work each day.

Officers will be expected to conduct these inspections several times during their shift and report on both the behavior of the workers and their general attitude toward getting with the program and description of sharp objects found at the site.

In addition to this Security Directive, a memo to all work sites will be issued about the flat tire problem here in the community and the need to keep the roadway clear of nails and screws. The memo will also include the penalty levied on repeat offenders and uncooperative site workers.

Day/Swing/Graveyard Patrol Officers

Re - ***NAILS – SCREWS – SHARP OBJECTS AT WORK SITES***

This is a directive with orders for all AUS Day/Swing/Graveyard Patrol Officers to immediately begin compliance during your respective work shifts.

Beginning today, you are directed to stop at each construction site, park your vehicle, get out and walk the roadway, the RR parking area and the work site up to the front of the garage to look for NAILS – SCREWS – SHARP METAL SCRAPS that can get tracked out onto the road and cause tire damage.

You are directed to conduct this inspection at all construction sites at least three times during your shift.

Any and all nails, screws and sharp objects are to be collected and turned over to your supervisor with notes added to your daily report indicating the site address and a brief description of items found, plus any notes regarding the attitude of the workers in cooperating with this program.

NOTICE TO CONSTRUCTION SITES

To - All Construction/Remodel Managers and Site Workers

From - Donal S. Russell, General Manager

Re - *NAILS – SCREWS – SHARP OBJECTS AT WORK SITES*

This notice is to bring your attention to the issue of nails, screws and other miscellaneous sharp objects falling onto the roadway from workers' vehicles, transferring demolition debris to dumpsters, dropping nails and screws from workers going back and forth from the site to their vehicles to get tools, equipment, etc.

Security will be conducting daily road inspections at each work site and making reports on nails and screws found. Continued careless behavior with workers ignoring this notice or demonstrating a negative attitude will result in the following:

- A worker may be banned from access for a period of time
- The entire job site may be closed to access by all workers for a period of time
